

## Spartan College Moving & Storage Moving Agreement

The service provider agrees to provide the following services for the customer subject to the following terms and conditions:

### 1. Services Provided

1.1 The Service Provider agrees to provide storage and delivery services for the customer's belongings during the agreed-upon dates, in accordance with the terms and conditions outlined in this Contract.

1.2 The Service Provider shall collect the customer's belongings from their dormitory or any other place of housing at the end of the school year and transport and store them in a secure and insured storage facility.

1.3 The Service Provider shall deliver the customer's belongings to their designated dormitory or place of housing upon their return for the upcoming academic year within the agreed-upon date.

1.4 The Service Provider has no legal obligation to store the customer's belongings past the agreed-upon delivery date. If belongings are left or abandoned, the customer agrees to transfer ownership of the items to the Service Provider.

### 2. Access to Belongings

2.1 The Service Provider is not required to provide access to the customer.

2.2 If extenuating circumstances arise the Service Provider may grant the customer access to the customer's belongings at the Service Provider's discretion.

### 3. Customer's Responsibilities

3.1 In the event of damage or loss of property the customer shall notify Spartan College Moving & Storage no later than 14 days after the return of stored items. Spartan College Moving & Storage, at its discretion, may inspect the damaged item(s) or request that the customer prepare an itemized list of damaged items and document the extent of the damage. Spartan College Moving & Storage reserves the right to submit such evidence as is available to its insurance carrier for adjustment of the loss/damage.

3.2 The types of loss and/or damage to the customer's goods or property are specifically limited to those perils or causes of loss, including all applicable terms and conditions, for which Spartan College Moving & Storage is afforded protection by its own insurer. There shall be no consequences or damages.

3.3 All mattresses must be contained within a mattress bag prior to storage. The customer shall provide their own mattress bag or purchase a mattress bag from Spartan College Moving & Storage.

3.4 As a condition for making a claim for damage, electronic property and/or devices of any kind will be contained in the original manufacturer's packaging that is also of sufficient strength acceptable to Spartan College Moving & Storage. Spartan College Moving & Storage retains the right to deny storage or shipping of any items that are deemed to be inadequately packaged or too fragile.

3.5 Spartan College Moving & Storage is not responsible for the functioning condition of any electronic device, for the loss or damage of any data withheld in an electronic device, or for any previously damaged or repaired items.

3.6 Full payment must be made at or before the pickup of the customer's items. If a check is returned for insufficient funds, the customer will receive a \$50 fine in addition to the cost of their order.

3.7 The customer agrees that illegal items will not be given to Spartan College Moving & Storage as a part of their order. If an illegal item is discovered within a customer's order, said customer will assume full legal responsibility. Prohibited items include, but are not limited to all illegal, dangerous, explosive, harmful materials, or chemicals, drugs, alcohol, acid, compressed gas, paint, firearms, stolen goods, food/perishables, living things, aerosols, and odor or fume-emitting substances.

#### 4. Insurance

4.1 It is agreed that the customer's property will be insured for an amount no greater than \$5,000 for all the customer's property in possession of Spartan College Moving & Storage or the value(s) stated in this section.

4.2 It is agreed that all property or goods in the possession of Spartan College Moving & Storage are insured at a value of no more than \$50 per standalone or boxed item (exceptions apply) in the event of damage to them due only to the company's negligence. This policy applies to all items held for any service provided by Spartan College Moving & Storage regardless of whether the insured value is less than the actual value of the item(s) contained within the stored box or container.

4.3 Exceptions to insurance coverage are provided below:

Inadequately packaged items, electronics not contained within the original manufacturer's packaging, any damages sustained without evidence of mishandling, negligence, or harm to outer packaging materials. (e.g., box), storage containers, highly fragile items (glass, fine china, etc.), cash, jewelry, collectibles, and items of non-monetary value (sentimental value, etc.).

4.4 The customer assumes responsibility for property losses or damages that exceed the total insurance value of \$50 and will not claim that Spartan College Moving & Storage or any of its employees and or affiliates are liable for additional property damage due to any cause.

#### 5. Entire Agreement

5.1 This contract constitutes the entire agreement between the Service Provider and the customer and supersedes any prior agreements, whether written or oral, relating to the subject matter herein.

5.2 This contract expires 14 days after the delivery of the customer's items.
